BRANCH CLOSING POLICY

It shall be the policy of Cornerstone Bank to have a distribution system that effectively and efficiently delivers products and services to our customers. For a number of years, the delivery of financial products was conducted through our Main Bank. Due to the need and convenience of our customer base and potential growth, the Bank has established a branching and ATM network to better serve our local community.

All branches and ATMs are expected to be competitive in the marketplace and profitable. Accordingly, we will from time-to-time re-evaluate our branch network and determine if a branch must be closed or hours rescheduled to meet the demands of our customer base. The following procedures will be followed if a branch is to be closed:

BEFORE CLOSING A BRANCH

- 1. We will evaluate the data in regard to the overall volume of all financial products and services within each branch and the profitability of each.
- 2. We will try to identify changes in staffing, products offered, use of space and other items that could make an unprofitable branch profitable.
- 3. We will try to identify ways to increase the volume or mix of business at the branch to increase its profitability.
- 4. If we find it necessary to close a branch in a community or area that affects low-tomoderate income individuals and businesses, we will meet with the community or group leaders to discuss measures that could help keep the branch open.
- 5. If we find it necessary to close a branch, we will notify the appropriate regulatory agency and provide notice to customers affected, in accordance with the provisions of section 39 of the Federal Deposit Insurance Act.
